HURRICANE SEASON

If you are going to be away from your home for an extended period of time, please remember to prepare for a storm by following these steps: removing furniture, potted plants, decorations, or anything that might be blown around in a high wind and cause damage to your home or a neighbor's home. Also remember to have a person (a neighbor or nearby relative) or firm designated to inspect your home for damage after a storm.

Storm shutters are only to be installed or closed when a Hurricane Watch is issued for Martin County by the National Weather Service. Shutters are to be opened/removed when no longer necessary for storm protection.

MAINTENANCE OF EXTERIOR OF HOME

Each owner is responsible for maintaining the exterior of their home including privacy walls and fences.

SUGGESTION: As a courtesy to your neighbor and the community, walk around your entire home from time to time to detect if any maintenance or power washing is in order. The privacy wall is often neglected and is the first to need cleaning.

WILD ANIMAL FEEDING

Florida Fish & Wildlife rules and regulations state in addition to being dangerous, it is **ILLEGAL** to feed alligators and Sandhill cranes. Not only is it in the animal's best interest not to feed them but your neighbor's too.

REMINDER

Please keep sidewalks clear of parked cars, bikes, toys, etc.; garbage cans are to be kept inside the garage; garage doors kept closed unless actively engaged in a project; decorative lighting is low voltage only and only in plant beds, not along the walkways. No parking is allowed on the street overnight.

Our concerned Retreat volunteers are willing to provide:

- Transportation to medical appointments
- Rides for grocery shopping or hair appointments
- Prescription drug, grocery and mail pick-ups
- Check-in phone calls or personal visits
- Occasional meal preparation.

We are pleased to report that over the past six months, we have had a definite increase in requests for our services. Since October 2018, we have received 23 requests from nine of our residents. Fourteen different volunteers graciously gave of their time to respond to all requests received. Our volunteers have primarily provided transportation to medical appointments and made meals for folks returning home after being hospitalized.

I have heard some residents comment that they were reluctant to ask for our assistance because they didn't want to bother us or thought they should only call if they were really in an emergency situation. We have over 20 volunteers waiting to be asked. So, if you or someone you know in the Retreat is in need of RAN services, simply contact one of the RAN facilitators listed below.






