New ADT/Devcon Contract By Dave Williams

The Retreat signed a new contract extension with ADT/Devcon Security. The HOA pays a basic fee per home for your alarm system. The rate for the past contract was \$13.85 per home per month and now will be \$11.85, a \$2.00 per home per month savings for the contract extension of 6 years. In addition we received a \$5,500 bonus for signing 5 months prior to our contract expiration. All inclusive, this saves our association about \$85,420 over the 6 year contract period.

Also, all 555 owners will be offered new device options that can be connected to your system via Wi-Fi and to the monitoring center by 4G cellular. Our current system needs a hard-wired phone line to communicate with the monitoring center. An example would be to purchase a carbon monoxide detector to be placed in your laundry room. It would communicate with your alarm panel via Wi-Fi. If you keep your existing hardwired phone line an alarm would be sent through it to the monitoring center. Thanks to all who have volunteered to be part of this committee. All volunteers will be contacted and asked to attend an informational meeting about our system. A tour of the system both on and off the property will be part of the learning event.

4. Our documents are in the process of being updated by our lawyer. It will include bringing our documents to date with current HOA laws and Florida statutes and also delete references to neighborhoods, the builder and the developer.

5. In response to residents' inquiries, a survey pertaining to hurricane shutters will be in the next quarterly mailing.

6. Bids are being reviewed to replace the 8' culvert pipe located in the Park and used for Retreat drainage.

7. The Retreat has received the settlement check for \$46,750 for the Double Tree vs. the Retreat suit. We are both moving forward with new attitudes, a more specific agreement and better, shorter, and cheaper mediation options in the event of future disagreements.

8. Your volunteer Board of Directors has reviewed options to respond to resident concerns that the new shed could be located in a better location.

Our objectives for this review were:

1. Make the shed as inconspicuous as possible, especially from the pool and clubhouse.

2. Protect the community investment in the new Polaris ATV vehicle in as secure a location as possible.

3. Limit the costs involved with any action.

We considered many alternatives and selected the best relocation site that met our objectives. We agreed to move the shed to a location further back and closer to the tennis court, rotate it 180° and install plantings and a trellis or two for camouflage/ beautification.

This is the least costly alternative that meets the goals. The target is to complete the move and install by September 15, 2014. The shed is installed to Martin County standards and is tied down to South Florida Hurricane standards.

Pharmacy Topics

EBOLA HEMORRHAGIC FEVER (Ebola HF)

As of this writing, the Ebola virus has already killed more than 900 people in West Africa. This week, a missionary physician working in Liberia who contracted Ebola hemorrhagic fever, was brought to the United States from Africa and was safely escorted into a specialized isolation unit at Emory University Hospital for treatment. Another fellow missionary, also infected, is to be flown back to the same facility. Emory has an isolation unit that was established in collaboration with the Atlanta-based U.S. Centers for Disease Control and Prevention (CDC). The unit is completely separate from other patient areas and is one of only four such facilities in the country.

Fear that this outbreak could now spread throughout the U.S. has generated considerable anxiety and controversy among our citizens. The purpose of my article is to provide some information about this deadly virus' transmission, treatment, and most importantly, the prevention of its spread.

Ebola hemorrhagic fever (Ebola HF) is one of numerous viral hemorrhagic fevers. It is a severe, often fatal disease in humans and nonhuman primates (such as monkeys, gorillas, and chimpanzees).

It is caused by infection with a virus of the genus *Ebolavirus*. The first *Ebolavirus* species was discovered in 1976 in what is now the Democratic Republic of the Congo near the Ebola River. Since then, outbreaks have appeared sporadically – until now.

The natural source host of the Ebola virus remains unknown. However, on the basis of available evidence and the nature of similar viruses, researchers believe that the virus is zoonotic (animal-borne) with bats being the most likely reservoir.

Transmission

When an infection does occur in humans, there are several ways in which the virus can be transmitted to others. These include:

- direct contact with the blood or secretions of an infected person, and/or
- exposure to objects (such as needles) that have been contaminated with infected secretions.

The good news is that this virus is not airborne, thus it is easier to contain. The viruses that cause Ebola HF are often spread through families and friends because they come in close contact with infectious secretions when caring for ill persons.

During outbreaks of Ebola HF, the disease can spread quickly within health care settings (such as a clinic or hospital) where hospital employees are not wearing appropriate protective equipment, such as masks, gowns, and

Proper cleaning and disposal of instruments, such as needles and syringes, is also important. If instruments are not disposable, they must be sterilized before being used again. Without

adequate sterilization of the instruments, virus transmission can continue and amplify an outbreak.

Signs and Symptoms of Ebola HF

Symptoms usually occur 8 – 10 days after exposure to the Ebola virus. Specific signs and symptoms vary, but often include marked fever, fatigue, dizziness, muscle aches, loss of strength, and exhaustion. Patients with severe cases often show signs of bleeding under the skin, in internal organs, or from body orifices like the mouth, eyes, or ears. Severely ill patient cases may also show shock, nervous system malfunction, coma, delirium, and seizures.

Treatment

There is no proven cure for the virus. It kills an estimated 60 percent to 80 percent of the people it infects, but American doctors in Africa say the mortality rate would be much lower in a better functioning health care system.

Standard treatment for Ebola HF is still limited to supportive therapy. This may consist of balancing the patient's fluids and electrolytes; maintaining their oxygen status and blood pressure; and treating them for any complicating infections. Stabilizing the patient, allows the body's immune system to try and eradicate the infection on its own.

Timely treatment of Ebola HF is important, but challenging, since the disease is difficult to diagnose clinically in the early stages of infection. Because early symptoms such as headache and fever are so nonspecific, cases of Ebola HF may be initially misdiagnosed.

If a person has the early symptoms of Ebola HF and there is reason to believe that Ebola HF should be considered, the patient should be isolated and public health professionals notified. Supportive therapy can continue with proper protective clothing until samples from the patient are tested to confirm infection.

Experimental treatments have been tested and proven effective in animal models but have not yet been tested in humans. In today's news, an experimental serum, called Zmapp (currently in animal testing phase by Mapp Biopharmaceutical Inc.) shows some promise – and, apparently was given to the two missionaries in Africa when it became evident that they were infected.

Prevention

With the exception of yellow fever and Argentine hemorrhagic fever, for which vaccines have been developed, no vaccine exists that can protect against this disease. When cases of the disease do appear, there is increased risk of transmission within health care settings. Therefore, health care workers must be able to recognize a case of Ebola HF and be ready to employ practical viral hemorrhagic fever isolation precautions or barrier nursing techniques. They should also have the capability to request diagnostic tests or prepare samples for shipping and testing elsewhere.

While it is very scary knowing that this virus now exists in our country, we have the best facilities in the world to deal with this situation and the best chance to develop a treatment and/or a vaccination that would finally eradicate this virus from the world. The CDC states that a vaccine could be ready for human testing as early as September.

The Retreat Architectural Control Committee (ACC)

Did you know that you need approval by The Retreat ACC before changing or adding to the exterior or grounds of your home? You must submit an ACC CHANGE APPLICATION to the Management Office and follow the instructions as outlined on the Retreat Website.

The ACC meets monthly on the 3rd Thursday to review and approve/disapprove your applications. Applications are due on the Monday before each meeting at noon. All are invited to attend.

system phone number and thus you could get rid of your hardwired phone system. With this new technology you can purchase many devices (smoke detectors, glass breakage, key fob) for a onetime cost for the device only and its monitoring through ADT/Devcon is included at no additional cost no matter the number of devices added. If you add certain devices you will probably be eligible for homeowner insurance discounts. The new contract will offer each homeowner many options from not changing your current service to updating to a newer integrated alarm system with added devices.

We will be holding community informational meetings to explain the options starting in December when many more residents can attend. ADT/Devcon company representatives will answer any questions and present the options. These meetings will be scheduled at various times and possibly we can have a presentation at the annual meeting in February. ADT and The Retreat look forward to your being able to take advantage of our new contract offerings.

The BOD wishes to thank residents, **Tom Hartnett and Ernie Spengler** for all their contract ground work investigating security companies. They met with and compared 5-6 different companies and their services before recommending that the BOD extend our existing contract with ADT/Devcon. A lot of time and effort was expended by them and we will all benefit from the results.

Channel 63 – Content Creator

Description of Duties

The **Content Creator** role is responsible for the creation and maintenance of the Channel 63 slide show. The slide show is televised over the Comcast provided Channel 63 to all Retreat residents. The individual should have a good knowledge of Microsoft Windows, Microsoft Powerpoint and ability to navigate through a variety of situations (blips) that may occur (i.e. Management Office computer needs to be rebooted, lost internet connection, etc.).

A basic knowledge of MS Powerpoint is essential to create individual slides and an understanding of the proprietary software (MediaZone Editor Pro) used to arrange the slides and upload to the player computer for broadcast. Of course, training in the use of MediaZone Editor software will be provided.

The Content Creator is typically notified by the chairperson of the Communications Committee, a Board of Director member or the Property Manager or other committee chair to post something on Channel 63. This might be a notice for an upcoming Board meeting or an event planned for the Women's Club, etc. Whatever the information is the Content Creator would take that info and format it onto a slide. He/she can take the liberty to add artwork to the slide to make it more attractive for viewing. Once completed the slide is inserted into the current CH63 slideshow and uploaded to the player computer attached to the Comcast broadcast equipment.

Presently the creation of the individual slide is created at the home of the Content Creator, but can be created by remote access (via LogMeIn) on the MediaPro Editor computer in the Management office. Either way the new slide and the current slide show is maintained on the MediaZone Pro computer.

Depending upon the season and the activity within the Retreat the typical tasks performed by the Content Creator is a weekly job that lasts no more than 30 minutes.

Coral Snake Sighting

This morning as I was walking along Glacier Terrace I saw a Coral snake winding its way up one of the driveways. Once it reached the shrubs on the border, it worked its way under the cover of the plant. I was quite surprised to see it. Coral snakes are usually elusive. They tend to burrow under dirt and dead leaves but they do become more active when it rains.

These snakes are quite colorful and pretty to look at but are very dangerous. Their powerful venom attacks the nervous system. They do not have fangs like pit vipers. Their mouth and teeth are small and they have a pair of venom- injecting teeth that are fixed in the front of the mouth. Not usually aggressive, these snakes flee when confronted. They bite only when stepped on or cornered.

Coral snakes are not to be confused with the Scarlet King Snake, a non-poisonous snake that has similar coloring. The way to distinguish between the two is that the Coral snake has a black snout and the red and yellow bands usually touch one another. That's where the saying, "Red and yellow kill a fellow" comes from.

I just thought I'd share my observations with you and to let folks know that because of our rainy season these snakes might be more active and out in the open. Residents should be cautious when reaching into bushes without looking and certainly should pay attention to young children and pets when they are outside.
